2. REPORTS

Document-by-Document

Application must be received along with all official copies of degrees, diplomas and/or certificates. A complete transcript must be submitted if a GPA is required. This report is suggested for Employment, Immigration, and to Further Education where a breakdown of courses and credit isn't required

Course-by-Course report w/GPA

Application must be received along with all official copies of degrees, diplomas and/or certificates and a complete transcripts or mark sheets for all courses studied. Additional documents may be requested by JCTraductions after initial review.

3. MISCELLANEOUS

- a) **Credentials:** Legible, official copies of all original language documents must be submitted with certified English translation
- b) **Translations:** Photocopies of original language documents, from which certified translations have been made, must be attached. Non English speaking countries whose institutions issue records directly in English must submit English records.
- c) **Documents request:** In case of insufficient information or incomplete documentation, a request for additional documentation will be

issued. An evaluation report will be issued only after all materials have been submitted. Failure to respond within 3 months will result in termination of the application and forfeiture of all fees. There will be no refund of any fees paid. A new application will have to be submitted thereafter.

- d) JCTraductions reserves the right to review original documents for verification purposes.

4. FEES
